- Proof of Pre-Acceptance Immunizations and Vaccinations Students who are admitted in the program must provide documentation of the following on the first day of class.
  - One diphtheria, tetanus, and pertussis (Tdap) vaccination that has been obtained within the last ten years.
  - o Influenza vaccination obtained in October of the interview year.
  - Documentation of blood test (serology, titers) showing immunity to MMR, varicella, or the Hepatitis B virus OR

Two doses of the Measles, Mumps, and Rubella (MMR) vaccine with each given at least 28 days apart.

Two doses of the varicella vaccine with each given at least 28 days apart.

Three doses of the Hepatitis B vaccine.

- Additional vaccinations or immunizations may be required by clinical affiliates throughout the program to include COVID-19 vaccines.

In order to comply with the clinical education affiliates, all students participating in clinical rotations must undergo a drug screen. The cost of this drug screen shall be absorbed by the student. Any student wishing to participate in clinical rotations may be required to undergo a urine drug screen as required by the clinical affiliate within the thirty (30) days preceding commencement of the clinical rotation. The drug screen due date will be provided to the students by the director of clinical education during the latter part of the fall semester. The site has the right to express an additional drug screen anytime during the externship.
